Therefore, Plaintiff did not offer sufficient evidence regarding the amount of actual loss that resulted from Defendants' conduct.

Accordingly, there is a reasonable basis in law to conclude that Plaintiffs \$5,000.00 offer is excessive. (ii) Willful and Malicious Injuries The evidence submitted by the Plaintiff is sufficient to demonstrate that Plaintiff's computer was damaged as a result of Defendants' actions. However, Plaintiff failed to offer proof that Defendants willfully or maliciously damaged Plaintiff's property. Accordingly, the Court finds that Plaintiff's \$5,000.00 offer is excessive.
